### Overview of FMK activities

Below is a brief summary of the activities that took place in the reserve during the past ten months. More detail will be provided when point 7 of the agenda is dealt with.

- Clearing of invader plants weekly work group, monthly hacks and individuals.
- Spreading of biocontrol agents as part of an integrated plan to attempt to control the spreading of invader plants
- Guided walks with experts in their field tree walks

- Monitoring the health of the spruit through miniSASS and full SASS (South African Scoring System).
- Monitoring the health of the spruit through WaterCan, an OUTA initiative.
- Monitoring the health of the spruit with FreshWater Watch citizen science water quality monitoring kits, an initiative driven by Ground Truth, FreshWater Watch and the World Water Quality Alliance.
- Maintaining the bird hide and toilets.
- Maintaining the foot paths and fixing fences.

# Registering Friends of Moreleta Kloof with the Receiver of Revenue

During the year a person who donated money to FMK requested a section 18A tax certificate. As we are not registered with SARS we cannot issue 18A certificates – we normally do this through WESSA. I discussed this with ReachOut Financial Services and they suggested that we register with SARS. The process will be started shortly.

- The pollution of the spruit is still of great concern, especially the sewer leaks from the residential areas around the reserve.
- Lack of participation of Friends of Moreletakloof members.
- Lack of funds for projects and general maintenance.
- Development of ptn of stand 88 we will monitor the situation.
